I hereby confirm my reservation to the stallion Windhover Crown Royal B-52852 for the 2024 season.

The 2024 Stud fee for breeding above named mare to this stallion is **\$550**. Payment due with contract, before the breeding of the mare. Stud fee is non-refundable but may be transferred to another mare. Live cover is subject to the show season and our travel schedule. Please contact us for show and/or travel dates.

I understand that the mare owner shall assume all responsibility for the condition of the mare and shall bear all risks of loss or damage to the mare whether by death, disease, injury, infection or otherwise, and by any cause whatsoever, and therefore agrees to hold the stallion owner, keeper or agent harmless for any and all damages associated therewith. This statement covers both live cover.

If the mare is determined to be unsuitable for breeding, the mare owner may substitute a new mare, subject to acceptance of a new breeding mare by Windhover Farm. This substitute mare shall be bred under the same terms and conditions as the original mare, as stated in this contract.

This contract provides for a return breeding for the following season (2025) for said mare (or agreed upon substitute) that fails to produce a live foal. "Live foal" is defined as one that stands and nurses. This will be satisfied by re-breeding at the mare owner's expense. In the event no live foal is produced, we must be notified in writing by a licensed veterinarian within 48 hours of birth.

The live foal guarantee mentioned in the paragraph above is expressly contingent upon the mare owner properly caring for the pregnant mare. Proper care shall include, but shall not necessarily be limited to, proper feeding and nutrition, regular deworming with products approved for pregnant mares, vaccinations that are customary in the mare owner's geographical area and proper intervention during foaling if necessary.

All foals sired by Windhover Crown Royal are eligible for either full-Welsh registration or half-Welsh registration with the Welsh Pony and Cob Society of America (WPCSA).

Mares 11 - 14 hands may be presented for live cover. All mares being presented for live cover must have a veterinarian signed clean culture and current coggins.

When the mare owner signs and returns this contract, it becomes a binding contract on both parties, subject to the above terms and conditions. This contract is not transferable or assignable without written permission. The mare owner irrevocably agrees that his/her sole recourse against Windhover Farm with respect to the performance or non-performance of this contract is return of the stallion service fee. Stallion service fees are not refunded unless the stallion dies or becomes unfit for service. In that eventuality, the mare owner may choose a refund of the service fee.
